• Entry fee is non-refundable if accepted.

• Application must be accompanied by a **CHECK** for booth space plus \$5.00 a foot for any chuckwagon over 14' long.

## **SPECIAL NOTES**

1. Upon acceptance you will be assigned a setup time.
2. Vendor agrees that if accepted by promoter, that promoter is under no obligation to rent space to vendor in future years.

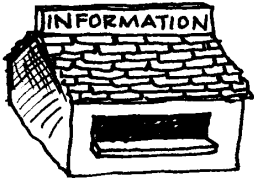
## **FESTIVAL RULES**

1. Food vendors spaces measure approximately 8' deep x 14' wide. If your chuckwagon, including tongue, is larger than this, **you will be required to pay an additional \$5.00/foot.** Strictly enforced.
2. Food vendors are required to have all necessary state and city permits. These permits must be posted in your booth.
3. Vendors must use heavy duty grounded cords only (12 gauge wire minimum). Cords should be 75' to 100' in length. No household extension cords will be allowed.
4. Proper fire extinguishers are required in all booths.
5. You will be allowed 20 minutes to load and unload from a designated area.
6. No pets, bikes or soliciting in park.
7. No exceptions can be made to the above rules. Food vendors not meeting booth space and electrical requirements will be asked to leave the park and forfeit space fee.
8. Prices must be posted before opening for business.
9. After acceptance of food menu, no substitutes will be accepted, unless by committee approval.
10. The Committee will not be responsible for any accidents.
11. Bring containers w/ covers to haul your own grease waste.

The Art in the Park Festival is held in conjunction with Mandan Rodeo Days and Fourth of July Celebration. It has grown to be a popular event, attracting over 25,000 to 30,000 visitors from across North Dakota and surrounding states.

Location of the festival is in the Robert Dykshoorn Park which is along the parade route on Main Street in Mandan. It will host art and craft booths as well as food booths and cultural entertainment. Proceeds of our shows have gone toward park improvements. Previous monies have paid for landscaping, underground sprinkling systems and band shell. This year the Festival grounds have been expanded to facilitate more artists and craft booths.
